Resources for Storm Damage Recovery for Forest Landowners

Hurricane Florence caused over \$70 million in significant damage to forest and timber land through wind and flooding. If you did suffer timber damage during the recent storm the first place to start is to contact your [consulting forester](#) or the [N.C. Forest Service County Ranger](#). However, keep in mind that these folks may be very busy or assisting with clean up. Be patient, the later the damage occurs in the season, the more time you have to salvage the timber. Avoiding Timber Theft or Encroachment

Loss of trees and timber value can take place anytime. For example, if there are any logging operations in the area, landowners should walk the line with the adjacent landowner and/or logger to prevent property line misunderstandings. They should inspect the property during, and several days after, the neighbor's harvest looking for signs of illegal access or cut trees. The fact that the property is being watched may help prevent harvesting mistakes or timber theft. [Read more here.](#)



New Financial Assistance Sources for Northeastern NC Forest Landowners

In October, two new financial assistance options for forest landowners in northeastern North Carolina were announced by the Roanoke Center's Sustainable Forestry and Land Retention Project (SFLRP).


1. Funding ([Hurry deadline November 2nd!](#)) for EQIP and RCPP cost-share programs to implement practices such as tree and shrub establishment and prescribed burning in Bertie, Chowan, Gates, Halifax, and Hertford counties.
2. To assist the region's many forest landowners who don't have current forest management plans, the SFLRP is offering up to \$1,000 per landowner to aid in management plan development.
