Managing this part of your property requires some knowledge and planning. Dr. Jim Rice, Extension Fisheries Specialist, has developed a free Pond Management Guide. This publication presents the basic principles of managing recreational ponds and the requirements for producing and maintaining high-quality fishing in a pond. Some common mistakes in pond management and ways of solving pond problems are discussed. This information should allow you to develop and carry out a pond management plan that provides maximum benefits.
